## Guidance notes

### In what circumstances will a death grant be paid?

The Local Government Pension Scheme provides for the payment of a lump sum death grant in the case of a member who dies:

- In service (from 1 April 2008 three times actual pensionable pay).
- After leaving, where benefits have not been transferred to another scheme (normally equivalent to 5 times annual pension).
- Whilst receiving payment of pension benefits (but only in limited circumstances).

### How many beneficiaries can I nominate?

You may nominate one or more beneficiaries. If you decide to nominate more than one beneficiary, you must clearly state the proportion of the death grant which is to be paid to each beneficiary. You should make sure that the total of the proportions equals 100%.

### Who may I nominate as a beneficiary?

You may nominate any person, whether or not they are related to you or are financially dependent on you. You may also nominate an unincorporated or incorporated body, a charity, a club or a society.

### Can I nominate a beneficiary under 18 years of age?

If any of the beneficiaries you nominate are under 18, you should indicate what you wish to be done with the money prior to the child reaching age 18, preferably by nominating someone to open a trustee account on behalf of the child.

### Can I revise my nominations?

You may revise your nomination at any time by completing another nomination form. You can get extra forms from the pension scheme administrators, ESCC, or download forms from [www.eastsussexpensionfund.org](http://www.eastsussexpensionfund.org).

### Is the Council bound by my nominations?

In the event of a death grant becoming payable, the Council will normally distribute the money in accordance with your wishes. However, the Council is not legally bound to pay the lump sum to a nominated beneficiary and will take account of your circumstances at the time; for instance, your family circumstances may have changed since the date of your nomination. It is important, therefore, that you keep your nomination up to date.

Please note that the Council is unable to offer legal advice. You are advised to consult a solicitor if you need legal advice in connection with your death grant nomination.
